<u>Eran – Webmaster – DCM District 36</u> – Absent.

<u>Ian R. – District Liaison</u> – General Service Conference agenda items are a big deal. District 34 and 37 just had a workshop on 3/23/19 in Stockton. Noreen A. (our DCM) brought many things for the GSRs to share back with their groups. The pre-conference assembly for our district is April 13-14, 2019 in Nevada City, CA.

There was discussion on how groups donated to the different areas or levels of AA. Although it is suggested that each fellowship support all four levels (GSO, District, Intergroup, Area Committee), the District shows 33 fellowships registered and only 9% of these make contributions to the District. The suggested level of support is as follows:

GSO - 30%

District - 10%

Intergroup/Central Office – 50%

Area Committee – 10%

There may be some misunderstanding from fellowships that contributing to the GSO means our district will get money, but that is not the case. District right now is financially in a good position and is supporting our GSRs in funding 2 men's hotel rooms and 2 women's hotel rooms and their registrations for attending meetings.

<u>Ian R. – PI/CPC</u> – Meets the third Sunday of the month from 2:30pm – 3:30pm at Northside Fellowship. Looking to change the meeting currently schedule for April 21st (Easter Sunday) to Sunday, April 28th.

Actively stocking literature racks in various locations. Somehow the rack at Memorial Hospital went missing/lost and even the NA rack disappeared. Several presentations to organizations are pending. Currently John is working to get legitimate officials that know ASA rules to volunteer for the tournament at no cost to CVI. Each fellowship has a packet that has the registration form (cost per team is \$100) and one (1) player release form that must be completed by all players. Fellowships can make copies for each player to complete. AA Members ONLY can play on a team and must be 18 years or older - no RINGERS allowed. For small fellowships not hosting a team, please let members know that there will be a "free agent list" from which teams can pull players for vacant slots.

Committee would like to bring in a guest speaker from Los Angeles, Linda Moss, with 35 years. She and her son will be coming and would also like to play in the tournament. Housing and travel costs of approximately \$354 would be needed. Last year the budget for the event was about \$1500. These speaker costs would increase the event costs. There will be a pulled pork sandwich lunch like last year with chips, side disch, and beverage. There will also be a snack bar

available throughout the day. Ian motioned to approve the increase in budget and Bert seconded. Motion passed.

City of Modesto is requiring special insurance to include them as an additional insured, but CVI apparently does have that kind of insurance. CVI needs to look into that.

Ada L. – CVI NCCAA Liaison- At the Foster City NCCAA conference, Mary M. was voted in as the new Treasurer. The next conference is June 7, 8, and 9 in Rocklin, CA.
