No noon meeting on Saturdays. They too have new chair and alternates from central and eastern time zones for Zoom meetings. Birthday speaker meeting is virtual.

<u>Eric R.- Living Sober</u> – Absent, But Jim G. reported that they have face-to-face meetings daily at noon, 6pm, and 8pm, including a men's and women's meeting. Had elections and all slots were filled. Attendance is pretty decent. Birthday and business meetings are virtual.
